GENERAL REGULATION ON THE PROTECTION OF PERSONAL DATA - 2018

INFORMATION FOR INDIVIDUAL CLIENTS

The General Regulation on the Protection of Personal Data – European Parliament and Council Regulation nº 2016/679 of 27 April 2016, comes into force as of 25 May 2018, which establishes the rules in relation to the protection, processing and free circulation of the personal data of individuals and which applies directly to all entities involved in the processing of such data in any member State of the European Union, specifically Portugal.

The purpose of this notification is to inform you of the new rules applicable to the processing of your personal data and the rights you have, in addition to informing you of the manner in which you can manage the respective consents in a direct and simple way.

Within the scope and for the purposes of the commercial services we provide you with, BCH – Comércio de Vinhos, S.A., insofar as it determines the means and ends of the processing procedure, is the entity entrusted with processing your personal data and guaranteeing the protection of your privacy, operating in accordance with the law and the new Regulation.

Our records include your personal data obtained pursuant to the business relationship you have established with our company, specifically and essentially in the acquisition of our products. This data has been collected pursuant to the contractual obligation consisting of the tax and accounting requirements necessary for due compliance with the laws of Portugal.

In the event you wish for your data to be kept for potential future purchases, it will be stored in our accounts database, in the Artsoft system, and can only be accessed by our personnel, and will not be disclosed to any third party or used for any purposes other than those for which it has been obtained. In the event you wish for your data to be deleted or stored in our DPO (Data Protection Officer) system, where it will not be available to anyone entering the system, you should send us this information via email to geral@herdadecalada.com.

Your personal data may be disclosed to legal, tax and regulatory authorities in order to ensure compliance with any legal requirements we are bound by.

You have the right to access your personal data at any time, in addition to, within the limits of the agreement conditions and the Regulation, change, oppose the respective processing, decide on the automatic treatment of the data, withdraw your consent and exercise the other rights set forth in the law.

In accordance with the provisions of the Regulation, you have the right to be notified in the event your personal data is violated, whereby you may file a complaint with the respective authority(ies).
